Fishing harbours to be dredged

Sand accumulated over the years is hindering boats

MANGALORE: Clearing apprehensions voiced by officials, Minister for Fisheries Anand Asnotikar on Friday said that the Government would buy a dredge to remove sand from fishing harbours. The sand accumulated over the years is proving to be a hindrance to fishing boats.

He told presspersons here that the Government would, after buying the dredge, appoint a private agency to operate it for a fee.

The Government would seek Central assistance in purchasing the dredge after preparing a detailed report on the cost and operational expenses. The Karnataka Fisheries Development Corporation (KFDC) would be asked to purchase it, he said.

Earlier, during a meeting with KFDC and Fisheries Department officials, KFDC Managing Director V.K. Shetty and Joint Director of the department Gangadhar V. Maddikeri expressed reservations about the proposal.

Mr. Shetty said that dredging was the responsibility of the Ports Department. Mr. Maddikeri said the Centre had a scheme that provided 75 per cent of the cost of dredging. He said this scheme could be made use of instead of purchasing a dredge. Maintenance of the equipment would become a problem, he said and it would prove to be a proverbial white elephant.

Mr. Maddikeri suggested that the Government could set aside Rs. 5 crore a year

for dredging and invite global tenders.Mr. Asnotikar said ports in Mangalore and

Honnavar would be developed at a cost of Rs. 65 crore each, and the one in Malpe

at a cost of Rs. 53 crore.

Farmers urged to grow cocoa as an inter crop

COIMBATORE: As there is a good price for cocoa beans – Rs. 160 a kg – coconut

farmers can augment their income by growing cocoa as an inter crop, the Vice-

Chancellor of Tamil Nadu Agricultural University (TNAU) P. Murugesa Boopathi,

has suggested.

Speaking at the annual research meet on Palm Crops at the university recently, the Vice-Chancellor said TNAU would take up trials in farmers' fields to standardise packages of practices for growing cocoa as an inter crop. "The university is planning to produce good quality cocoa planting material for the benefit of farmers," he added.

He also said that since palmyrah was a subsistence crop for the economically weaker sections, the university had plans to take up new schemes on the plant. Growing palmyrah had several advantages, especially for effective soil conservation.

P. Rethinam, former Executive Director, Asian and Pacific Coconut Committee, Jakarta, and former Director, Coconut Development Board, said the causes for low productivity included old and senile plantations, sparse population, non-descriptive varieties, poor soil fertility management, pest and diseases, inappropriate soil and water management, and natural disasters like cyclone and droughts.

Since tender coconuts fetched a good price, farmers were urged to earmark 50 per cent of the area for its cultivation.

Bench refuses to review ban on lotus cultivation

Orders issued in public interest

MADURAI: The Madras High Court Bench here on Thursday dismissed a petition filed by the Kanyakumari District Lotus Flower Producers and Contractors Welfare Society to review an order passed by the court on November 12 directing the Kanyakumari District Collector and the Public Works Department officials not to

lease out any water body in the district for cultivating lotus plants after the expiry of

the lease agreements in force.

No necessity

A Division Bench comprising Justice F.M. Ibrahim Kalifulla and Justice K.B.K.

Vasuki held that there was no necessity to review the order as it had been passed

only after taking into account both the pros and cons of banning lotus cultivation in

Kanyakumari district.

Solid grounds

The court had issued the orders in public interest because cultivating the lotus

plants might turn the floating beds into solid grounds, they said. A Bench

comprising Justice D. Murugesan and Justice S. Nagamuthu had passed the

original order on November 12.

Order

Then, they said: "Lotus, prized for its serene beauty, is perhaps the most

spectacular plant in the aquatic environment. In India, its flower is associated with

the Goddess of Wealth. It is also used for medicinal purposes. Above all, it is our

National flower... But if grown on a commercial basis, the consequences would be

disastrous."

Farmers demand 50% internal reservation

Out of 33% seats for women in Parliament

Farmers demand payment of Rs.2500 per tonne for sugarcane from next season

TNEB urged to supply power for 6 hours in the morning and 8 hours at night

VELLORE: The president of the Tamil Nadu Farmers Association M.R. Sivasamy has demanded 50% internal reservation for representatives from farmers' families from out of the 33% of the seats proposed to be reserved for women in Parliament and Legislative Assemblies.

In a release, Dr. Sivasamy said that whichever party comes to power, agriculture is neglected. Therefore, the government should provide for 50% internal reservation, in order to ensure the implementation of the demands of farmers. The farmers' body president demanded payment of Rs.2500 per tonne for sugarcane from the next season. The price of Rs.2000 per tonne announced by the Tamil Nadu government includes the cutting charges and lorry transport charges. He wanted the government to announce Rs.2500 per tonne, excluding transport and cutting charges.

Dr. Sivasamy urged the Tamil Nadu Electricity Board to supply power for agricultural purposes for six hours in the morning and eight hours in the night.

At present, power supply for agriculture was effected only for three hours each in the morning and night. Besides, farmers also suffered unscheduled power cuts, which seriously affected the farm operations.

The association president said that the farmers belonging to the association would be staging an agitation in front of the offices of the forest department, revenue department and local bodies in Pernambut on April 12 in support of their above demands, as well as other demands including lifting the ban on transport of jaggery for trade, permission for toddy tapping, waiver of loans and ban on import of palmolein.

Sugar price eases in metros

New Delhi, April 9: The government today said that the price of sugar, which had skyrocketed to around Rs 50 per kg in mid-January, has declined in Kolkata, Mumbai and New Delhi.

"According to data collected by the department of consumer affairs, sugar prices have declined at Delhi, Shimla, Mumbai, Jaipur, Kolkata, and Thiruvananthapuram and remained steady at all other reporting centres, barring Bhubaneswar," the government said in a statement.

The price of the sweetener has fallen sharply in the last two months and is likely to remain under pressure going forward on expectations of higher availability from two leading sugar producing states — Maharashtra and Uttar Pradesh.

Sugar prices are hovering in the range between Rs 34 and Rs 36 a kg in the metros. Meanwhile, wheat prices have decreased at Delhi, Lucknow and Bengaluru and remained steady at all other reporting centres except for an increase at Bhopal, the government said. The prices of pulses, potatoes, onions and edible oil were unchanged at most places during the first week of the month.

Relocation of fishing harbours mooted

CHENNAI: The National Shipping Board has deliberated on a proposal to shift fishing harbours from the proximity of major ports on security grounds.

Speaking to reporters after the board's meeting here on Friday, Chairman of National Shipping Board Capt P V K Mohan told reporters that major ports have been asked to come up with proposals in the next Indian Ports Association (IPA) meeting.

Detailing on the advantages of the proposal, which he claimed was under "study" and would help officials to differentiate merchant ships and fishing vessels, he said it would also help the expansion of ports. Conveying that the Vizag port had already submitted a blueprint for shifting the fishing harbour to a place nearly 30 km away from it, he pointed out that the move would affect the livelihood of the traditional fishermen. But it would benefit the fishing harbours to acquire more infrastructure like exclusive wharfs and warehouses.

It may be recalled that there was a plan to relocate Kasimedu fishing harbour from its present location, which faced stiff resistance.
