## State-level training programme for farmers begins

KRISHNAGIRI: A three day State-level training programme for farmers on the Management of Non-Monetary Inputs in Crop Production began at the Regional Research Station of the Tamil Nadu Agricultural University at Paiyur in Krishnagiri district on Thursday.

Thirty farmers from 15 districts are participating in the three-day residential programme.

Inaugurating the training, V. Thirumalai, Assistant General Manager, National Bank for Agriculture and Rural Development, said that the dwindling number of farmers was a cause for concern. With a view to improve this, NABARD was taking all efforts through various programmes in rural areas. NABARD was conducting Capacity Building through Adoption of Technology (CAT) for farmers through various training programmes such as System of Rice Intensification, Green House, precision farming and tissue culture.

As many as 30 such training programmes were sponsored by NABARD in the State, out of which the Krishnagiri district got the lion's share of seven training programmes.

In his presidential address, A.K. Mani, Head and Professor of the Regional Research Station, said manpower shortage hampers agriculture sector.

To offset this, the RRS was sensitizing the farmers on adopting various low cost technologies to reap maximum benefits.

A release issued from the district administration says he asked people to approach officials of various departments to know about Government schemes and ways to derive benefit there from. The release is based on his address at the monthly grievance meeting at N. Thayirpalayam village in Nasiyanur town panchayat.

## **Court backs farmers' right to irrigation facilities**

MADURAI: The right of agriculturalists to enjoy irrigation facilities is, in a way, a part of the fundamental Right to Life guaranteed under Article 21 of the Constitution, the Madras High Court Bench here has observed.

A Division Bench, comprising Justice D. Murugesan and Justice S. Nagamuthu, also said that attempts to bring in development in other sectors at the cost of agriculture would prove detrimental to national interest.

They made the observations while setting aside a notification issued by a District Revenue Officer for acquiring lands, passing through two waterbodies, to widen National Highway 67 between Tiruchi and Karur.

They directed the National Highways Authority of India (NHAI) to form a committee of experts for visiting the site and exploring the possibility of realigning the road, thereby minimising the disturbance to the waterbodies.

The Tiruchi Collector and the Chief Engineer of the Public Works Department were directed to extend assistance to the committee to facilitate completion of roadwidening works before July based on the agreement entered with contractors.

The agriculturalists, who are the beneficiaries of the Punganoor and Kallikudi water tanks, were permitted to submit written objections, if any, before the committee, which should take them into consideration before arriving at a decision.

The orders were passed while disposing of two writ petitions, one filed by the Tamil Nadu Agriculturists Association of the Manikandam Panchayat Union in Tiruchi district and another by a farmer hailing from the same place.

Writing the judgment, Mr. Justice Nagamuthu said: "It is true that formation of a road under a national project is as important as any other project.

But, while doing so, every endeavour should be taken to minimise disturbance to irrigation resources.

"In recent times, growing scarcity and competition for water stand as major threat to future advancement in poverty alleviation. It is needless to say that food production is likely to be affected if our irrigation sources are not preserved."

The judge also said that it was the primary responsibility of the government to protect natural water resources besides ensuring the livelihood of agriculturalists and marginal farmers as 65 per cent of the population was involved in the agricultural sector.

## **Tuticorin farmers seek relief**
